

WASK/WKOA/WKHY/WXXB Contest Rules

ELIGIBILITY: Employees and families of WASK/WKOA/WKHY/WXXB, their agencies and employees and families of any radio, television or cable company or its subsidiaries are ineligible to participate in or win the contest. WASK/WKOA/WKHY/WXXB reserves the right to disqualify any contestant who is financed, aided, encouraged or prompted by an employee or family member of any radio, television or cable company or its subsidiaries within 75 miles of Lafayette, Indiana. WASK/WKOA/WKHY/WXXB reserves the right to disqualify any contestant if WASK/WKOA/WKHY/WXXB deems the contest rules were not followed. WASK/WKOA/WKHY/WXXB reserve the right to enforce the following: **No contest winners or their “family member” whether they are on-air or off, shall be allowed to win consecutively inside a 30-day period. Any person who has won any contest on WASK/WKOA/WKHY/WXXB or “family member” is again eligible to win another contest only after 30 days have passed since their previous win.** This includes all contests pertaining to the station. A person or family member will be allowed to register for a consecutive contest as long as the winning dates are 30 days apart. Each person is limited to one registration per contest. WASK/WKOA/WKHY/WXXB contests are void when and where prohibited by law. **Repeat offenders of the eligibility rule will be banned from winning prizes from WASK/WKOA/WKHY/WXXB. Prizes must be redeemed at 3575 McCarty Lane, Monday- Friday, between the hours of 8:30am and 4:30pm.**

PRIZES: All prizes awarded through WASK/WKOA/WKHY/WXXB are not non-transferable nor may a prize be substituted at the request of a contest winner. The prize indicated by station personnel to be won in a contest is the only prize awarded and given only to the person who is designated as the winner. WASK/WKOA/WKHY/WXXB reserves the right to substitute a prize or equal or greater value in the event the specified prize offered is unavailable. All prizes awarded by WASK/WKOA/WKHY/WXXB must be claimed within 30 days of the date the prize is won. No substitution will be made for violation of this 30-day rule. If a winner does not claim his/her prize within the 30-day period, the prize is forfeited and eligibility restrictions mentioned in these rules still apply to that winner for future contests. All prizes designated for pick-up at the WASK/WKOA/WKHY/WXXB studios must be picked up during regular business hours. **WASK/WKOA/WKHY/WXXB will not be responsible for any prizes lost or stolen in the mail.**

RELEASE: WASK/WKOA/WKHY/WXXB and/or a sponsor participating in a contest on WASK/WKOA/WKHY/WXXB may require a release form to be completed by the winner and any other person or persons involved in accepting a prize. Upon accepting any contest prize from WASK/WKOA/WKHY/WXXB or sponsor participating in a contest on WASK/WKOA/WKHY/WXXB, winner releases WASK/WKOA/WKHY/WXXB and any and all sponsors of any liability or further claims. WASK/WKOA/WKHY/WXXB may use voice recordings to prevent contest fraud. WASK/WKOA/WKHY/WXXB cannot be held liable or responsible for any telephone failures, malfunctions or irregularities during a contest or can WASK/WKOA/WKHY/WXXB be liable for any discrepancies by the US Postal Service or any delivery service or courier involved in delivering the prizes, entries or contest information to or from WASK/WKOA/WKHY/WXXB, not is WASK/WKOA/WKHY/WXXB to be held liable for any lost or stolen entries, prizes or contest information. The decision of the judges is final. All winners are responsible for reporting and paying taxes on prizes received. All entrants agree to grant WASK/WKOA/WKHY/WXXB unlimited use of their name, voice, picture, quotation or facsimile, without consideration, in conjunction with their participation in any given contest.

IDENTIFICATION: In order for a winner to claim a prize, WASK/WKOA/WKHY/WXXB requires picture identification. WASK/WKOA/WKHY/WXXB may require any or all of the following: driver's license, state ID, passport, and/or birth certificate. WASK/WKOA/WKHY/WXXB reserves the right to examine additional identification and may choose to accept or deny awarding the prize based on the identification presented. WASK/WKOA/WKHY/WXXB requires a contestant to truthfully respond with all pertinent information it deems necessary for station records including but not restricted to legal name and address, telephone number, birth date and social security number. WASK/WKOA/WKHY/WXXB may disqualify a contest winner immediately upon learning the contestant has responded with all pertinent information it deems necessary for station records including but not restricted to legal name, address, telephone number, birth date and social security number. WASK/WKOA/WKHY/WXXB may disqualify a contest immediately upon learning the contestant has responded with false information.

TYPE: For trivia-related or game-related contests, winners must supply the “answer that we’re looking for” to win. Decision of the studio judge is final. For sweepstakes-related contests, registration forms must contain all information requested in a legible manner.

CHANGE: WASK/WKOA/WKHY/WXXB reserves the right to extend the contest if it so desires. WASK/WKOA/WKHY/WXXB reserves the right to make necessary changes to the contest rules and procedures. In the event of any dispute pertaining to this contest, the decision of WASK/WKOA/WKHY/WXXB management is final.

OTHER: Specific contests may have additional stipulations not listed here. Refer to documents pertaining to those contests for specific rules.
